Wine 100 leads

For measurements in air 1 meter above ground, It was 1 msv/year.

So the Japanese government and TEPCO promised, "Moving from the evacuation centers back to the contaminated areas Will only occur after
These safe radiation levels have been reached
And decontamination is complete."

But at some point, 100 bq/kg quietly became 8000 bq/kg (an 80-fold increase) And 1 msv/year 20 msv/year (20-fold)

The prime minister issued a directive

Lifting the evacuation order for areas under 20 msv/year, declaring: "Three years have passed. Now, let us pull together fully and lift our spirits.

Most of you 140,000 evacuees can return home as your areas become safe."

Accordingly, Fukushima prefecture also issued a directive to its

Elementary and junior high schools:

"Let's feed the children Fukushima-grown rice in their school lunches To show the world it's safe."

All radioactive topsoil
Measuring more than 8000 bq/kg
In expected resettlement areas
Has been removed.
But the removed soil has no place to go.
It's temporarily stored only under a vinyl covering.

The ones who most wish to forget about the radiation Are the people of Fukushima.

Yet, going back home,

## Note 1:

Bq=Becquerel, a unit for measuring radioactivity from materials. Sv is a unit that measures how much radiation a person has absorbed into the body. In connection with this, 5 msv/year and above is the international standard for defining a radiation controlled zone (this guide is used, for instance, for radiation for people who work in nuclear power production facilities and medical radiation facilities. Only those over 18 who are not pregnant are allowed to work in such areas). According to this criterion, all residents in areas around the Chernobyl accident with an ambient radiation of 5 msv/year were forced to move. Despite this, many cases of

Note 2: On March 20, 2014, the UN Special Ambassador on the Right to Health, Anand Grover, came to Japan and issued the following warning regarding the Japanese government's declaration that up to 20 msv/year is safe. This warning, also included in a published UN Report for the Japanese government in May of 2013, said, "We recommend that 1) health checks including blood screenings and urine screenings be implemented for those living in areas with radiation levels greater than 1 msv/year, and 2) A plan be put in place as early as possible to reduce radiation levels to less than 1 msv/year, and 3) the citizens participate in all government decisions regarding support for the victims.

Note 3: TEPCO = Tokyo Electric Power Company
